# MINUTES OF HOLBETON PARISH COUNCIL MEETING HELD ON TUESDAY 13 JUNE 2017 AT 7.30 PM IN THE VILLAGE HALL, HOLBETON

The Chairman welcomed Mr H Lopes, Mr P Brown and Mr A MacPherson. It was agreed to discuss planning application 1109/17/FUL - Land at Gnaton Farm, Yealmpton, Plymouth, PL8 2JA, at the start of the meeting.

Mr Lopes explained the proposal was a community-owned project committed to it via \$106. All benefits maintained by the local area. It is a development of a new solar farm (30 acres) with up to 7.3MWp of generating capacity, comprising the installation of solar photovoltaic panels and associated infrastructure. This would include electrical inverter and transformer cabins, switchgear and meter house, sub-station, access tracks, fencing, CCTV and landscape planting.

There will be an educational fund of £1000 per year, used by local primary schools (Yealmpton, Holbeton, Newton & Noss Mayo) with a pack available, and annual trips. Parishes will benefit from Community fund of £11,000 which will be split - Yealmpton being the host parish to have the majority, then the remainder to Holbeton, Newton and Noss Mayo. Mr Lopes confirmed the grass underneath the panels will be grazed by sheep. Mr Lopes stated the land is a well-hidden site and will be screened by a Devon Bank, 500 metres in length, to be established on the Northern boundary.

Cllr Baumer had walked around the site and felt it would not have a negative visual impact on the area. Mr Lopes confirmed neighbours of the site had been consulted and views and concerns discussed were covered. Cllr Ackroyd enquired who would be funding the development. Mr Lopes responded that approximately a third of the money would be from local investors, a third from national ethical investors and a third from financial investors. Planning consent would be granted for twenty-five years, and at the end of that period a further planning application could be made or the site reinstated. The panels have a lifespan of 40 years. The project is not government-subsidised and investors would receive an approximate 5% return on investment with any surpluses benefiting the local communities.

"Apologies for not reaching the meeting in time this evening. I have three Parish Council meetings that share the second Tuesday in the month and this will make it quite challenging to visit them all when they have a short Agenda.

There is relatively little to report at this moment in time. Devon & Somerset and Torbay Trading Standards are to merge. There has been some change to the structure of Scrutiny Committees at Devon County Council".

District Councillor Cllr Baldry's report was read by the Chairman: -

"I have been selected to chair the newly created SHDC Recycling and Refuse Working Group. Holbeton members may have seen a recent change which allows rinsed plastic-coated food and drink cartons (TetraPaks, fruit juice, yoghurt etc) to be recycled in the blue recycling bags. These cartons are mainly made from wood fibre which is a natural renewable. The process which does the recycling takes advantage of the wood fibres found in cartons and turns them into 100% recycled cardboard used for wrapping products such as cabling, and wrapping paper.

I attended the Licensing Committee meeting which discussed the application for Mothecombe Old School. I made representations about the proposed finish time and this was cut back by 30 minutes. With this change, I wish the venture every success and told the applicant so.

Still no news on progress on the Flete applications for Church Hill and Vicarage Hill".

Email 15/05/2017 - Update on Totnes Leisure Centre - South Hams District Council and Fusion Lifestyle can confirm that conversations held today with Tadpool and its solicitors, to enable the Leisure Centre in Totnes to remain open with Fusion as the operator, were very positive. Outstanding issues were discussed and the principle of how to resolve them was agreed. The three parties now need a little more time to complete this process, which would involve the drafting and reviewing of contracts. In order to allow time for this to happen, South Hams District Council has agreed to fund the operation of the centre for a further two weeks. This would ensure that the centre remains open for users while the contracts are being completed. Tadpool has also been asked to make a contribution towards this. The timetable for completing the contracts is now as follows: All three parties meeting Monday 22 May to review the final drafts of the contracts; the final documents will be issued for signing on Wednesday 24 May, with completion no later than Friday 26 May. If the three parties do not stick to this timetable, South Hams District Council will not fund the centre beyond Tuesday 30 May, and the dry side would then have to close.
