#### 008/21 PLANNING

Cllr Sherrell had declared a DPI and stood down at 7.20 pm, Deputy Chairman Cllr J Fuller chaired the meeting:

A presentation was given by Andy West (AW) from Verto.

The following questions were asked:

Cllr Ackroyd: -

Would the lumber yard be used for deliveries? - Andy West (AW) if SHDC are not happy with that proposed another site may be used.

S106 Affordable Housing? AW - five units on Eastern Side are affordable housing.

Concerned about pedestrian access to the dwellings - AW pointed out on the site plan, the 25 metre visibility splay.

There are residents who have concerns about windows overlooking their properties - AW showed the plan of the property, which showed there will be two windows at first floor and one at ground floor elevation.

Site maintenance of hedges and hedging - AW replied that the northern boundary plot four is a hedge bank but some discussion which might change to black railings following discussion with Historic England.

Maintenance of boundary hedge which is on the lane - AW confirmed the estate management company will look after the open space. Devon County Council will adopt a path

Cllr Hollett: -

What heating systems are being used in the houses? - AW replied that ground or air source pumps and PV panels flush with the roofline. The houses are designed to have net zero emissions.

Lighting energy source - AW responded that PV drives the lighting. Halogen or LED bulb, the internal specification to be decided. Will car charging points be installed - AW responded that at the moment one car charging point to be provided.

Will there be street lighting - AW confirmed there are no plans for lighting other than low level lighting for the public car parking spaces, at the moment.

Are the houses lease or freehold - AW confirmed the properties would be# freehold

Cllr Baumer: -

What is the estimated cost for managing the open space - AW was not able to give a firm figure for managing the open space.

Would the fee apply to the affordable housing - AW it would depend on the registered providers of the affordable housing as some do and some do not.

Possibility of Parish Council and Flete Estate to have input on the affordable homes - AW the S106 agreement requires affordable housing. We would listen to views, but would have to also take into account the views of the registered providers.

Energy performance rating - AW highest rating will be achieved

Cllr Gunatillake:

Are they Passivehauses - AW no, but the building of the houses is carbon neutral.

How many communal carparking spaces - AW confirmed there is an allocation of two parking spaces for each house, some of the affordable will have one. Total of twenty spaces in the communal carparking area.

Tom (parishioner) showed slides to discuss his concerns with the planning application:

Has spoken to Andy West at Verto and wished to thank him for his help to date. Drainage is a concern - current proposal is to allow surface water to be put in to the combined Holbeton sewage and surface water pipes. The sewerage plant, which is now named as a water treatment plant, is not able to deal with the current capacity. Tankers are being used daily to take away raw sewage waste. Correspondence from South West Water to Verto, state they will be able to cope. Unhappy that drainage installation will ensure trees within the new development are being protected and their ash tree is not.

The ownership of the back up surface water drain and their maintenance near their property has not been confirmed.

John Mildmay White - my understanding is the estate owns the drain and has the responsibility to maintain it.

Cllr Baldry - SHDC Planning Officers will liaise with South West Water who have statutory powers. His concern is drainage for this site and he will need to be convinced that drainage has been dealt with. Cllr Baldry will ask Cllr Thomas to attend a Parish Council site meeting on Wednesday 12 May at noon. ACTION: Cllr Baldry

AW - a site meeting to take place on 17 May 2021 with a drainage engineer.

The meeting was Chaired by Cllr Sherrell from 8.50 pm.

## 013/21 HOLBETON PARISH COUNCIL CLIMATE CHANGE SUB-COMMITTEE UPDATE - Clir Baumer

The Holbeton Parish Council Climate Change subcommittee will have held its most recent meeting on Tuesday the 4th May, a zoom meeting.

This parish council meeting coming just 2 weeks after the last briefing, there is little additional to report.

As soon as preparations for the new wildflower area next to the Reading Rooms had been completed, a period
of drought set in. A watering rota had started, and now rain appears to have come just in time for the seeds sown last
month.

Artwork for the accompanying notice board has been completed, and a copy is attached. A local company, Colourbridge South West, will print this as a vinyl print with matt laminate onto 3mm aluminium composite with a 6" of chalkboard vinyl across the bottom. Their quote for £102 for this work is significantly below the amount previously approved, namely £150. Chris Bray has kindly agreed to make up a frame to hold this board. Resolved to approve the artwork on the notice board.

- Holbeton Cricket Club has failed to secure funding from Yealm Community Energy Community fund for a solar panel installation behind the cricket pavilion at Flete. They intend to continue to pursue further funding for the project.
- The two public electric car charge points that were to be funded by a Devon wide DELETTI (Devon Low-carbon Energy & Transport Technology Innovator) programme, will not be going ahead. The project requirements have been updated and now require land to be owned by participating councils.
- Parish councillors are thanked for emailing me with their sightings of early purple orchids around the parish, which are now out in flower. Six sites have been identified to date.
- The environmental library will be available from this week on Monday mornings. A list of available books is attached.
