# (b) County Councillor and District Councillor's Reports

# County Councillor R Hosking

Grit bins are being replenished, in addition a survey is being carried out to ensure are in the appropriate position and if they are required.

The issue of inconsiderate parking at Mothecombe to be discussed at a Devon County Council SCARF, (Speed Compliance Action Review Forum) meeting.

Devon County Council overspend of 8 million pounds due to increase of services.

#### District Councillor K Baldry

SHDC planning department is struggling with the number of planning applications being submitted, which has resulted in determination dates not being achieved.

#### District Councillor I Blackler

An improvement has been made to prompter dealings on calls to SHDC.

Improvements to town centres will have further consultations.

Only 20 complaints on 12 months to date were referred to the Ombudsman but only 3 were upheld.

A period of Purdah starts on 26th March next year during which funding of projects cannot be considered from localities funds etc.

There has been Planning overload in the second quarter of this year, hence delays were inevitable in giving decisions.

From a survey it has been noticed an improvement in waste collection

# (c) Questions from the public and Councillors

A parishioner enquired if there were any further developments on the Battisborough Cross police incident report. PCSO Andy Potter stated the incident involved visitors to the area, investigations are taking place but due to the serious of the incident he was not able to comment any further. Once the report is finalised, he will feedback.

A parishioner asked who decides and prioritises jobs on the highways? Also, they wish to raise safety concerns about the subsidence on the Ramsland to Wonwell road. Cllr Knight stated the road from Ramsland to Wonwell needs underpinning, DCC Highways are waiting for structural engineers as a section of road involves serious work. The recent road patching on Church Hill had been on the work list for months. When the Church Hill development has been completed the road will be resurfaced. Cllr Flower pointed out, the Parish Council have no control of DCC Highways and asked if parishioners could report highway issues on Devon County Council web site https://new.devon.gov.uk/roadsandtransport/report-a-problem/.

Cllr Hosking confirmed there is a schedule of repairs, but the budget is very tight. The neighbourhood contact for DCC Highways is Nick Colton.

Cllr Hearn asked who was responsible for removing weeds where the church wall joins the road. Cllr Hosking stated, if weeds are growing out of the church wall it is the responsibility of the church, if the weeds are growing out of the road it is DCC Highways.

#### 79/18 DEMENTIA FRIENDLY PARISHES AROUND THE YEALM PROJECT

The Chair of Dementia Friendly Parishes Around The Yealm Project, Liz Hitchins, reported on the work of the project. She pointed out, the person living with dementia cannot be changed, but all of us can change the experience they have in their community. The main aim of the project is to support and improve the lives of people living with dementia and their families. To enable people with dementia to remain active and involved in community life and work with local groups and organisations to develop suitable activities and service.

The project continues to raise awareness and understanding of dementia both locally and nationally. At the beginning of the month there was presentation in Barcelona by University of Plymouth in which the Yealm Project was mentioned.

Dementia Friendly Parishes Around The Yealm Project is also involved in the Four Rivers Dementia Alliance, to spread the good news of what we has done.

Parish Councils can think about how they can help those with disability to access their village hall, use parish footpaths etc.

We are extremely appreciative of the support of Holbeton Parish Council and particularly wish to thank Cllr Hearn for his time and hard work.

Cllr Ackroyd reported, Mr Bexley had left some money to contribute towards the ongoing maintenance of the garden. This will be held and ring fenced by the Parish Council.

# 84/18 REMOVAL OF A HEDGE AND THE CONSTRUCTION OF A NEW ENTRANCE ONTO THE HIGHWAY NEAR THE BULL AND BEAR

Mr Hockin was disappointed no one had spoken to him so that he could clarify the situation. The reason for the new entrance was to enable a farmer to unload their animals safely from a cattle lorry. Cllr Ackroyd asked what was planned for the area. Mr Hockin stated trees would be planted to promote habitat and the area would be landscaped.

It was pointed out to Mr Hockin, a previous planning application had been turned down and South Hams District Council Enforcement Department were aware of the situation. Mr Hockin would now apply for a retrospective planning application for access to the fields.

Post - October 2018 = Consultation to 03/12/2018 on the Main Modifications to Plymouth and South West Devon Joint Local Plan, a joint local plan with South Hams District Council and West Devon Borough - circulated to Councillors.

Martin Rich (Devon Communities Together) has confirmed he will be attending the Parish Council on 11 December 2018 meeting to discuss Smart Meters.

Holbeton Public Toilets - a parishioner has volunteered to clean the toilets during the winter for £10 a week. It was agreed, two independent building surveyors will assess the building prior to the Parish Council agreeing to owning the building.
