## 51/23 HOLBETON PARISH COUNCIL CLIMATE CHANGE SUB-COMMITTEE UPDATE - Clir Baumer

The meeting was held on Tuesday 4th July 2023. The main topics under consideration were:

- Follow up from the River Erme sewage public meeting Friday 18<sup>th</sup> November
- i) The meeting with representatives from South West Water on the 21<sup>st</sup> March 2023 to consider how to get the most from a proposed new surface water drain extending the existing from the school to part way up Vicarage Hill.

I wrote to SWW on behalf of the parish council and Flete estate on the 14th June as follows:

"Hi Vicky and Charlotte

many thanks for your amended minutes with added information following discussion with Hazel.

We would ask that you provide your report on the survey of existing drainage as agreed in March, and on your undertaking to facilitate a request for DCC to clean the gullies in Holbeton. As things stand at the moment this work by DCC has not been undertaken, and we fear that heavy rain following this prolonged dry spell could cause avoidable flooding.

We were of course disappointed to hear that SWW expected that the whole cost of a new surface water drain, estimated at between £400,000 and £500,000, would have to be borne by the developers of the planned new houses up Church Hill.

The parish council, meeting last night, expressed concerns that the cost of this new surface water drain, that would benefit not only the new houses but also existing properties, could prove prohibitive and put the development in jeopardy.

To date I have not received a reply. I have sent a follow up email.

ii) Support the development of a whole river group, the River Erme Water Quality Group.

Cllr Sherrell gave a short briefing on the meeting. The next meeting is planned for the 27th July.

To date the one briefing we have had from the "Wild About The Erme River" or WATER group was published in the Holbeton News. This identified the composition of the steering group, within which there are vacancies for the roles of administration, fundraising and finance. A copy of the steering group composition was circulated with this briefing.

## • An electric vehicle (EV) car charger for the village

Following last month's parish council meeting I spoke to our parishioner who had generously proposed that he would donate an EV car charger for Holbeton Village.

He indicated that he was not proposing to continue a dialogue with the village hall trustees. Instead of assisting the parish council with a feasibility study looking at all possible options to locate an EV charger, he is now proposing donating 3 EV chargers to the 3 of the 5 parish council alliance members who were the first to come up with a realistic proposal for locating it within their village.

The purpose of the charger remains to be to provide nearby reliable charging facilities for people wanting to buy or rent an electric car but without anywhere suitable to mount a car charger.

Whilst we have a small number of places to investigate the possibility, it is quite conceivable that our parish will not be one of the first 3 to get a free EV charger.

## A stand at this year's Yealmpton Show on the 26<sup>th</sup> July

There is one more meeting before the event, and we have already around half the posters for the different parishes' display boards. All parish councillors are of course welcome to attend the stand, the exact location for which has not been revealed. Thank you to those of you who have agreed to provide cover for the Holbeton Parish Council display board.
